DIRECTIONS: Do NOT use on people. This product is intended for household use only. If you or a member of your household is suffering from lice infestation, use topical **DEEP SIX Lice Treatment Spray**. Shake Well Before Use.

Hold nozzle back 30 inches from surfaces. Spray as a mist on pillows, pillow cases, sheets, bedding, scarfs, stuffed animals, any and all other household items that may have come into contact with an infected person. DO NOT saturate. Allow to air dry. Where possible, machine wash household items and dry at high temperature for 25 minutes. Repeat in 7-10 days to kill any newly hatched lice. DO NOT spray into eyes or mouth.
